Resonance 2012 Overview

Since 1977, Resonance has been a special place for women ... a place where hope and motivation replace shame as women learn to create a new life for themselves and their children. Through outpatient substance abuse counseling, re-entry support services and mentoring services, we are helping women challenged by the criminal justice system become self-sufficient. It is our goal to help troubled women change ... for good. As these women change, their families change and our community changes. Resonance offices in the historic Breene mansion and provides the following services for women:

Substance Abuse Services/Diversion Program

Licensed Professional Counselors work one-on-one and in groups with women struggling with substance abuse problems. Many women come to Resonance as part of court-ordered diversion programs such as Drug Court and Community Sentencing; through these programs, women are referred to Resonance and participate in a comprehensive substance abuse treatment program in lieu of incarceration. Women also are referred for services from Probation and Parole, Temporary Assistance for Needy Families and Child Welfare; women may self-refer for treatment if they are SoonerCare eligible.

Resonance provides only outpatient services. The duration of substance abuse treatment ranges from 90 days to three years, during which time clients live and work in the community learning to cope with everyday stressors throughout their recovery journey.

Women's Reentry Support Services

Resonance provides model re-entry services for non-violent offenders returning to Tulsa and the surrounding area. Case managers work with women while incarcerated to help them be successful as they release into the community.

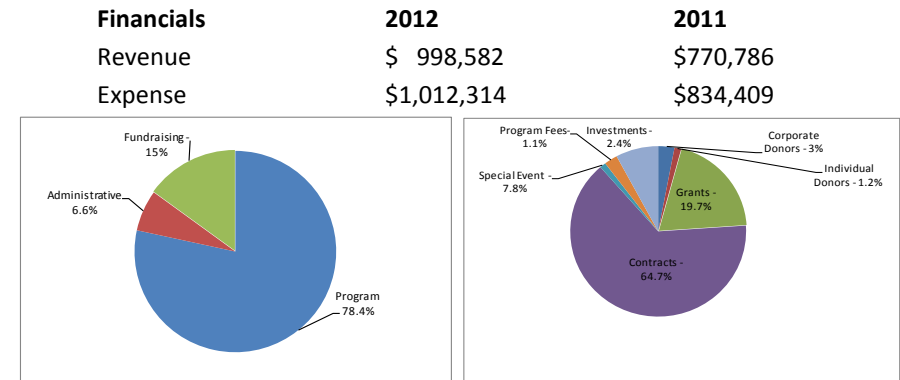
Working one-on-one with offenders three to six months prior to release, Resonance case managers develop individualized re-entry to assist women in developing a plan for success upon release.

Mentoring Program

The mentoring program offers clients a variety of benefits including peer support, positive role models and life-long connections. Meeting bi-weekly, the program curriculum incorporates healthy recreational activities with community resource information. However, the primary goal of the program is to foster camaraderie through positive peer group interaction while also developing a trusted one-on-one relationship with a female role model.

Women Served in 2012

Resonance served 596 women in 2012, with 257 women enrolling in substance abuse treatment. Thirty-five non-violent offenders graduated Resonance through the Drug Court Program, dedicating 18 months to three years of their lives to learning how to successfully manage their addiction. Instead of incarceration and possible continued substance abuse and recidivism, these women are sober, employed, paying taxes and serving as a positive role model for their children. Had these women been incarcerated, the cost to DOC and the state would have exceeded half a million dollars *per year* and added to an already overcrowded criminal justice system. In 2012, the Reentry program served 106 women and assisted 90% of enrollees in securing employment within 30 days of release and 99% in securing clean and sober housing. Finding employment within 30 days of release greatly reduces the odds of recidivism.
