Mission:

Resonance promotes and supports the well-being and self-sufficiency of women and their families challenged by their experience with the criminal justice system.

How Your Support Helped Women Change

- **551** women were served by Resonance in 2013 with 195 enrolling in substance abuse treatment.
- **54** women became clean and sober in lieu of incarceration, increasing their self-respect and ability to hold a job and care for their children
- **27** women were paired with caring mentors for support, guidance and positive role modeling
- **65** women released from prison and are employed, paying taxes and living in safe and sober housing
- **100s** of women are now productive, self-sufficient and serving as role models to their children

How Your Support Helped Families Change

- Our clients and their children are living in safe, drug-free housing.
- Hundreds of children now have a sober, employed parent caring for them.
- These same children are learning to view this as normal and expected behavior.
- These children will grow into adulthood emulating this work and parenting ethic.
- Underserved families throughout our community now have hope and a plan for the future.

How Your Support Helped Our Community Change

- **LESS CRIME**
Our community is safer with a decrease in illegal activity.
- **DECREASE IN UNEMPLOYMENT**
Our community has more tax-paying, employed women.

Additional 2013 Highlights

As good stewards of the funds entrusted to us, Resonance enhanced existing services, generated additional revenue streams and developed new programs to meet emerging needs in the community, including:

Choosing to CHANGE

Program Development

- Development and coordination of Choosing to Change re-entry program at Turley Correctional Facility to be implemented January 2014, in partnership with Planned Parenthood, Tulsa Community College, Girl Scouts of Eastern Oklahoma, and Workforce Tulsa

- Research and development of ADSAC services to further diversify revenue base
- Partnership with Junior League of Tulsa to develop social venture opportunities for clients

Client Services

- Community Counseling Services implemented to assist women self-referring for treatment
- Partnership and contractual agreement with Community Sentencing for treatment services
- 75 percent completion rate among Drug Court participants in substance abuse treatment
- Partnership with Tulsa Hub to provide bicycles as a means of transportation for clients
- Highest client satisfaction rate in Oklahoma for substance abuse treatment services*

Community Outreach

- Implementation of successful Stacked Deck fundraiser resulting in a 300 percent increased net profit, 20 percent increased attendance and an 18.5 percent profit/expense ratio
- Development of new Resonance website and video
- Development of an 18-member Advisory Council

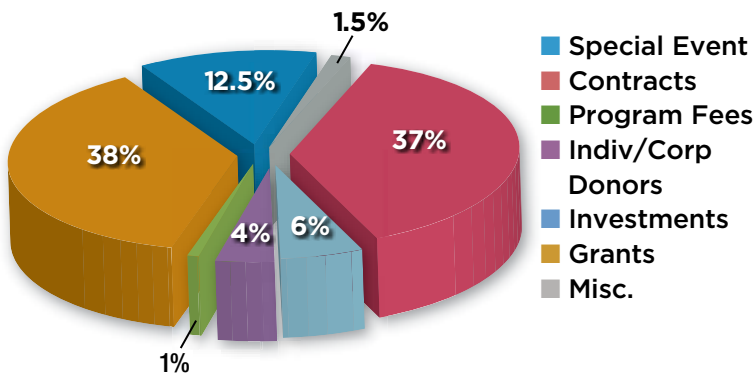

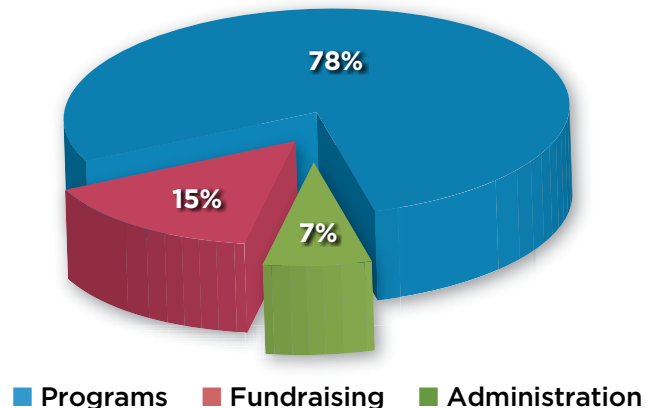

2013 Resonance Programs

Diversion Services

Licensed Professional Counselors work one-on-one and in groups with women struggling with substance abuse addiction. As part of the diversion program at Resonance, many women are referred for comprehensive substance abuse treatment in lieu of incarceration. The duration of substance abuse treatment for each woman ranges from 90 days to three years, during which time they live and work in the community, caring for their children and learning to cope with everyday life stressors throughout their recovery journey.

Women's Re-Entry Support Services

The Resonance Women's Re-Entry Program helps women successfully reintegrate back into the community upon release from prison. Incarcerated women face many barriers upon release. Armed with a felony record, many find difficulty securing employment and housing. They also have little money, no transportation and most likely, a substance abuse problem. Resonance case managers work with offenders at Mabel Bassett Correctional Facility, Eddie Warrior Correctional Facility and Turley Residential Center in developing a plan for a fresh, new beginning.

Mentoring Program

As part of Re-Entry Support Services, the Resonance Mentoring program offers women a variety of benefits including peer support, positive role models and lifelong connections. Program participants meet biweekly and the curriculum incorporates healthy recreational activities with community resource information. However, the primary goal of the program is to foster camaraderie through positive peer group interaction while also developing a trusted one-on-one relationship with a female role model.
